## **Objections and Sounding Alarm Over Threats to the National Security of the United States**

1. I am now sounding an alarm of biblical proportions as the corruption revealed in this lawsuit has taken on the highest level of importance to the national security of the United States of America, such I am uncertain the Defendant Judges, the two present Judges, and Assistant US Attorney John J. Stark want to maintain a position of declaring me a “*vexatious litigator*” supporting defenses that I failed to state a claim, lack of jurisdiction, and that this case is frivolous, because given what will soon be an unwinding of this lawsuit in the public arena, they will be deemed enemies of the United States of America, and righteously prosecuted and imprisoned.

2. My *Bardes v. Bush* (1:22-cv-290) defendants consisting of George Walker BUSH, Richard Bruce CHENEY, William Henry GATES, III, Lawrence Edward PAGE, Timothy Donald COOK,

MICROSOFT Corporation, ALPHABET, Inc., APPLE, Inc. along with unnamed John DOES consisting of Mark ZUCKERBERG and META, Jeff BEZOS and AMAZON, Warren BUFFETT, CISCO, ORACLE, GODADDY, along with former President's Barack Hussein OBAMA II and Joseph Robinette BIDEN Jr., members of the CIA, FBI, and DOJ, collectively referred to as *GOG AND MAGOG* (GOG is every other letter of GeOrGe, Magog are his loyalists) have committed crimes that not only caused my sufferings detailed in my Complaint, but have also compromised the national security of the United States to the communist nation of CHINA. This document details and provides the evidence of their betrayal of our great nation. Our laws now require their executions along with anyone else who supports their cause.

3. The corruption in this case started early. When I filed my Complaint on December 9, 2024, the case was assigned to Judge Matthew W. McFarland. Apparently, Judge McFarland did not want to be the judge on this case, so two days later, on December 11, 2024, the case was assigned to a long-retired judge named Judge Michael R. Barrett.

4. Judge Michael R. Barrett was a former next-door neighbor down the street on Grandin Road in Hyde Park where I grew up in Cincinnati. His parents and my parents were social friends and business colleagues. Judge Barrett's sister is my sister's best lifelong friend, and my sister is friends with Laura BUSH. My sister and her husband vacation with George and Laura BUSH.

So, when I saw this posted in PACER, I assumed Judge Barrett either volunteered to take on this case, or was specifically chosen to carry out further corruption for *GOG AND MAGOG*. I object to this corruption.

5. On December 17, 2024, I mailed via USPS 2-Day Priority Mail® (tracking# 9589071052701775038295) a letter to President elect Donald J. Trump ("TRUMP"), along with a copy of my lawsuit, to his residence in Florida, explaining who rigged the 2020 election and

who likely recruited Thomas Matthew Crooks to shoot him. I had a civic duty to inform TRUMP even though I do not support anything he does, and also as a hedge in case the CIA members of *GOG AND MAGOG* prevented my mailed copy of my Complaint to the DOJ from reaching anyone in Washington, DC. According to USPS tracking, my mailing to TRUMP was never delivered for weeks. I filed a missing mail report on the USPS website portal and never heard back.

6. On December 28, 2024, I mailed a second letter and copy of my lawsuit via USPS 2-Day Priority Mail® (tracking# 9505515209434363015011) to TRUMP in Florida, and it too went missing. I went back to the USPS missing mail portal, but was permanently locked out. But by early January, USPS tracking reported both mailings had been delivered together on December 30, 2024, at 1:44pm. This was a bogus backdating and evidence of the work of the CIA members of *GOG AND MAGOG* not wanting TRUMP to ever learn of my lawsuit. And obviously TRUMP never received my mailings.

7. Shortly after I filed my Complaint on December 9, 2024, I started having website visits from someone in Columbus, Ohio on the CIA's *Amazonaws* backbone. But I did not know who in Columbus would be visiting. All the members of *GOG AND MAGOG* use a common communication program issued by the CIA that displays a thumbnail image of my websites, such when members have a meeting about me, the thumbnail image refreshes the URL giving me the website hits in my log file which contains the IP address of the visitor, the date and time of the visit, and a string of data about the visitor. These website log visits are fully admissible in any court of law because they were voluntarily given to me by the visitor, plus the courts treat such log data as *irrefutable evidence* enough so to convict and imprison. But these visits let me know who is meeting with who, about me. George Walker BUSH has used the same proxy for ten

years, so he is easy to identify. William Henry Gates, III always uses Microsoft IP addresses, Lawrence PAGE uses Google's, Tim Cook uses Apple's, Mark Zuckerberg uses Facebook's, and same with the others. CHINA, who joined *GOG AND MAGOG* in 2018 after busting their own citizen and President of Interpol, Meng Hongwei, with accepting \$2.1 million dollars in bribes from BUSH to pass to the three judges of the International Criminal Court ("ICC") to vote against opening the BUSH war crimes investigation for using Cold Cell Torture to torture to death innocent Muslims, always visits my ColdCellTorture.com website using IP addresses that home deep in CHINA. CHINA agreed to keep BUSH secrets about the ICC bribes upon BUSH and GATES promising that TRUMP would lose the upcoming 2020 election. Because it was *GOG AND MAGOG* who rigged the election using GATES for undetectable access to any Windows® based computer through the operating system. See my Complaint for details. But CHINA has always been worried about my website ColdCellTorture.com for reasons that I published their involvement and complicit crimes. CHINA had grave concerns and did not want anyone to know their crimes.

8. After my Defendant Judges never answered my Complaint within the 60-day window (expired 2/10/2025,) and still have never answered in their individual capacity, eight days later on February 18, 2025, Assistant US Attorney John J. Stark filed a motion to dismiss under the name of his boss who had been fired by TRUMP four days prior for being a Black man appointed by BIDEN. Not realizing his mistake, which was hard to believe, John J. Stark refiled his motion under the name of an interim US Attorney. When I saw that John J. Stark was from Columbus, Ohio, it became clear that all those website visits between someone in Columbus on the CIA backbone and other members of *GOG AND MAGOG*, indicated that John J. Stark had been compromised by the CIA, and was a tool of organized crime.

9. But on February 11, 2025, I mailed a motion for summary judgement to the courthouse in Cincinnati along with required copies to the parties and the DOJ in Washington, DC. Two days later on February 13, 2025, I recorded a website visit from the DOJ in Washington, DC on the DOJ's IP address, letting me know someone received it. But it was someone unfriendly to TRUMP and US Attorney General Pam Bondi, and friendly to *GOG AND MAGOG*. Based on website visits over the past ten years, I estimate *GOG AND MAGOG* has about 120,000 members in the US government and worldwide including the countries of France, Canada, the UK, Australia, the Netherlands, Sweden, Japan, China, Turkey, Israel, and others.

10. On March 20, 2025 at 5:51pm, I had a website visitor to ColdCellTorture.com from Washington, DC on IP address 35.245.35.135. The visitor returned at 6:51pm and scanned in every page of the website. Minutes later, CIA agent and master of the CIA's use of Cold Cell Torture that tortured innocent Muslims to death, Jose Rodriguez visited the website, in apparent worry over the visitor. The visitor was never seen again.

11. *GOG AND MAGOG* are so worried about me, that they have a complete dragnet over everything I do. I use Yahoo email, so any hacker can get that, but *GOG AND MAGOG* watch the traffic to every website I own, everyone I email, everything I mail, and my phone calls are likely recorded and monitored. In what can only be described as God's retribution, it was this very gauntlet of surveillance that would lead to a disaster for them on May 6, 2025. A disaster that will lead to their ruin and effect their executions as to law. They were trapped in the very net they set for me.

12, On March 31, 2025, I had three visits from someone in Honolulu, Hawaii, home of Barack OBAMA. Below is the log entry from one of the visits:

The next day, on April 1, 2025, I had a website visit from both BUSH and OBAMA at the exact same time of 10:47am ET. GODADDY has the raw website log files to confirm. The website they visited was ironically WhyFearGod.com. Here are their log entries:

It is rare for OBAMA to visit, but common for BIDEN to visit from Wilmington, Delaware. But something was worrying OBAMA, such BUSH and OBAMA needed to meet with each other.

### **The ChinaGate Corruption Scandal**

13. In April, former Facebook executive Sarah Wynn-Williams published a book "*Careless People*" detailing how Facebook collaborated with the Chinese Communist Party to develop censorship tools and potentially access user data on citizens in the United States. META claimed the tell-all book was a "*mix of out-of-date and previously reported claims about the company and false accusations about our executives.*" On April 9, 2025, Wynn-Williams testified before the Senate Judiciary Subcommittee on Crime and Terrorism, sharing her allegations and urging further investigation into META's practices.

14. Five days later, on April 14, 2025, Mark ZUCKERBERG testified in the META antitrust trial and ***denied China had access to Facebook to spy on citizens in the United States.*** Mark ZUCKERBERG took the witness stand at 2:00pm ET, but was able to visit my website beforehand at 11:44am ET, letting me know what he was worried about. Below is the log entry

of his visit.

## **The Night of May 6, 2025**

15. Twenty-seven days later, on the evening of May 6, 2025 at 10:25pm, someone from Richmond, Virginia came to ColdCellTorture.com visiting a page about one of the eighteen inmates that have been murdered with cold cell torture in our jails and prisons. This visitor then posted the link to their Facebook account page. Their posting to Facebook immediately appeared on the feeds of four other Facebook friends, two of whom quickly clicked on the link visiting ColdCellTorture.com themselves.

16. This viral run on Facebook immediately alerted the Chinese authorities who were monitoring Facebook for any postings on Cold Cell Torture for any visits to ColdCellTorture.com. Three of the CHINESE criminals then visited ColdCellTorture.com giving me their hits and IP addresses. One of these CHINESE criminals then accessed the NSA Super Data Center in Salt Lake City, Utah to obtain the details on the visitors, while another one shut down the run on Facebook preventing any more users from finding the postings and links.

17. This proves not only did Mark ZUCKERBERG lie to congress about CHINA not having  
access to Facebook, it proves CHINA has what is called “*Full Access*” and “*Total Control*” of  
Facebook, as well as access to our nation’s most secure datacenter in Salt Lake City, Utah. This  
not only proves Edward Snowden’s claims about unauthorized domestic access to the NSA



databases; it proves foreign countries have access as well. This also proves that not only are my claims against my Defendant Judges in this lawsuit true, it further proves *GOG AND MAGOG* has betrayed our nation to the point our laws require their immediate arrests, mass trials, and then their swift executions.

18. Therefore, I object to Assistant US Attorney John J. Stark's motion to dismiss based on failure to state a claim, lack of jurisdiction, claims my lawsuit is frivolous, his demand that I be declared a *vexatious litigator*, and I demand his immediate arrest as a tool of the largest and most dangerous organized crime syndicate the earth has ever known. I further demand Magistrate Judge Peter B. Silvain, Jr. and Judge Michael R. Barrett immediately refer this case to authorities that have not been compromised by *GOG AND MAGOG*.
